TRANSFER OF DEVOLVED GRANTS TO LOCAL COUNCILS FISCAL YEAR 2018

THE MINISTRY OF FINANCE ANNOUNCES FOR THE INFORMATION OF THE GENERAL PUBLIC THAT THE GOVERNMENT OF SIERRA LEONE HAS ON TUESDAY, 11TH SEPTEMBER 2018 REMITTED A TOTAL AMOUNT OF **LE30,742,471,490** AS TRANSFERS FOR DEVOLVED FUNCTIONS TO 22 LOCAL COUNCILS, INCLUDING START UP COSTS FOR THE THREE NEW LOCAL COUNCILS OF PORT LOKO CITY, KARENE DISTRICT AND FALABA DISTRICT. THESE FUNDS HAVE BEEN PAID INTO THE ADMINISTRATIVE BANK ACCOUNTS OF THE LOCAL COUNCILS. THE FOLLOWING PROVIDE DETAILS OF PAYMENTS TO LOCAL COUNCILS:
