2. Bidders shall quote for all items as required in the Bid Document. Bids will be evaluated and contract will be awarded to the Bidder meeting the required qualification criteria.

3. Bidding will be conducted through International Competitive Bidding (ICB) procedures specified in the National Public Procurement Act 2016 and is open to all eligible bidders as defined in the manual.

The bidding document may be purchased by interested eligible Bidders upon the submission of a written application to the address below and upon payment of a non-refundable fee of **One Million Leones (Le1,000,000.00)** and bidders may obtain further information on the bidding document at the address below between 11:00 am to 4:00pm from Mondays to Fridays no-later than five (5) days prior to the deadline of submission of bids. The method of payment will be cash.

6. All Bids must be accompanied by a Bid Security in the amounts indicated above or its equivalent in a freely convertible currency. The Bidder shall seal the original and each copy of the bid, in separate envelopes, duly marking the envelopes as “**ORIGINAL (1)**” and “**COPY (3)**.” The envelopes shall then be enclosed in an outer envelope and sealed.

7. All bids must be accompanied by:

- Valid copy of NRA tax certificate;
- Valid NASSIT Clearance Certificate.
- Valid certificates of business registration;
- Valid City/District Council clearance certificate;
- A signed Integrity Pact
- Manufacturers Authorization
- Evidence of similar supplies
- Business Profile of the Bidder/Supplier

8. Bids must be delivered to the address below on or before 11:00 am on Tuesday 7<sup>th</sup> January, 2020. Electronic Bidding will *not* be permitted. Late Bids will be rejected.
