THIRD UPDATE ON COVID-19 ACCOUNTS – 22nd May 2020

As a follow up to our Public Notice on 8th May, 2020 on the operations of the COVID-19 Special Accounts, the General Public is hereby informed that cumulative donations into the COVID-19 Accounts at the Bank of Sierra Leone as at 21st May, 2020 is **Le 53,390,280,000** in the Leone Account and **US\$50,000** in the Foreign Account at the bank of Sierra Leone. Total expenditure is **Le43,086,816,357** and available balance is **Le10,303,463,643 plus US\$194.30**
