UPDATE ON COVID-19 ACCOUNTS

As a follow up to our Public Notice on 12th June, 2020 on the operations of the COVID-19 Special Accounts, the General Public is hereby informed that cumulative donations into the COVID-19 Accounts at the Bank of Sierra Leone as at 3rd July, 2020 is **Le124,754,060,400** in the Leone Account and **US\$55,920** in the Foreign Account at the bank of Sierra Leone. Total expenditure is **Le124,651,733,367** and available balance is **Le102,327,033 plus US\$7,203.29**.
